

ORDINANCE 1982 - 1

AN ORDINANCE OF THE TOWNSHIP OF MARION, BERKS COUNTY, PENNSYLVANIA, OPENING FOR PUBLIC USE AND TRAVEL A PORTION OF ALLEY "H" BETWEEN MAIN STREET, T-503 AND EXISTING ALLEY "G" HAVING A TOTAL WIDTH OF SIXTEEN FEET (16').

BE IT ENACTED AND ORDAINED by the Township of Marion, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

SECTION 1. The following portion of Alley "H" is hereby ordained as a public road of the Township of Marion, Berks County, Pennsylvania.

ALL THAT CERTAIN sixteen feet (16') wide alley known as Alley "H" as shown on Plan No. 7008-001-B-001 and dated February 10, 1982, prepared by Spotts, Stevens and McCoy, Inc., Consulting Engineers of Wyomissing, Pennsylvania, in the Village of Stouchsburg, in the Township of Marion, County of Berks, and Commonwealth of Pennsylvania, and being more fully bounded and described as follows, to wit:

BEGINNING at a P.K. nail in the Township Road T-503, known as Main Street and thence extending in a southerly direction to the south side of the aforesaid Main Street six feet (6.00') to the True Point of Beginning; thence continuing on the same line in a southerly direction, the aforesaid line located three and fifty hundredths feet (3.50') west of the easterly right-of-way line, by properties to the west of Curtis G. Himmelberger and Shirley A. Himmelberger, his wife, and on the east by property of William G. Barnhart and Sarajeon K. Barnhart, his wife, a distance of two hundred thirty-nine feet (239.00') to a point on the northern right-of-way line of Alley "G", said point being located seven and eighty hundredths feet (7.80') north of a P.K. nail located in Alley "G" and being the terminus of the herein described Alley "H".

SECTION 2. The alignment and grade of the aforescribed portion of Alley "H" between Main Street, T-503 and the existing Alley "G" shall be in accordance with the plans as prepared by Spotts, Stevens, and McCoy, Inc., Township

Engineers, Drawing No. 7008-001-B-001 and being on record in the Office of the Township Secretary of the Township of Marion, Berks County, Pennsylvania.

SECTION 3. The Township Engineer be and is hereby authorized and directed to take whatever steps are necessary to carry out the provisions of this Ordinance.

SECTION 4. All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance be and the same are hereby repealed.

SECTION 5. This Ordinance shall become effective thirty days after the date of enactment as provided by law.


