AN ORDINANCE OF THE BOARD OF SUPERVISORS OF MARION TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. 1993-2 TO CORRECT A TYPOGRAPHICAL ERROR AND TO MODIFY THE REGULATION GOVERNING THE STARTING AND ENDING HOURS WHEN OPEN FIRES MAY BE SET.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Marion Township, Berks County, Pennsylvania, and it is hereby Enacted and Ordained by the authority of the

- 1. The definition of "open fire" set forth in Section 1 of Ordinance No. 1993-2 is herein amended by deleting the word "of" and in its place substituting the word "or".
- 2. Section 3.2.G. of Ordinance No. 1993-2 is herein repealed and is replaced as follows:
 - G. all such burning shall take place in the daylight hours between dawn and dusk.
- 3. This ordinance shall become effective five (5) days after the date of its enactment.
