MARION TOWNSHIP BERKS COUNTY, PENNSYLVANIA ORDINANCE NO. 2021 3 2

AN ORDINANCE OF MARION TOWNSHIP, BERKS COUNTY, PENNSYLVANIA, AUTHORIZING THE INSTALLATION OF CERTAIN STOP SIGN AHEAD SIGNS IN BOTH DIRECTIONS ALONG KETTERMAN HILL ROAD (T-488) APPROACHING THE INTERSECTION OF KETTERMAN HILL ROAD (T-488) AND STOUCHSBURG ROAD (T-499) AND CERTAIN DANGEROUS INTERSECTION SIGNS IN ALL FOUR DIRECTIONS APPROACHING THE INTERSECTION OF KETTERMAN HILL ROAD (T-488) AND STOUCHSBURG ROAD (T-499).

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors of Marion Township, Berks County, Pennsylvania and it is hereby ordained and enacted by the authority of the same, as follows:

SECTION 1. In the interest of public safety and the health and general welfare of the community, the Township Board of Supervisors hereby authorizes the installation of a Pennsylvania Department of Transportation approved "Stop Sign Ahead" signs on the following:

- (i) the northbound side of Ketterman Hill Road (T-488) located two hundred feet from the intersection of Ketterman Hill Road (T-488) and Stouchsburg Road (T-499); and
- (ii) the southbound side of Ketterman Hill Road (T-488) located two hundred (200) feet from the intersection of Ketterman Hill Road (T-488) and Stouchsburg Road (T-499).

SECTION 2. In the interest of public safety and the health and general welfare of the community, the Township Board of Supervisors hereby authorizes the installation of a Pennsylvania Department of Transportation approved "Dangerous Intersection" signs on the following:

- (i) the northbound side of Ketterman Hill Road (T-488) located sixty (60) feet from the intersection of Ketterman Hill Road (T-488) and Stouchsburg Road (T-499);
- (ii) the southbound side of Ketterman Hill Road (T-488) located sixty (60) feet from the intersection of Ketterman Hill Road (T-488) and Stouchsburg Road (T-499);
- (iii) on the westbound side of Stouchsburg Road (T-499) located two hundred (200) feet from the intersection of Ketterman Hill Road (T-488) and Stouchsburg Road (T-499); and
- (iv) on the eastbound side of Stouchsburg Road (T-499) located two hundred (200) feet from the intersection of Ketterman Hill Road (T-488) and Stouchsburg Road (T-499).

SECTION 3. The provisions of this Ordinance are severable, and if any section, sentence, clause, part or provision hereof shall be held to be illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Township that such Ordinance would have been enacted if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

SECTION 4. All ordinances or parts of ordinances of this Township which are inconsistent herewith are hereby repealed.

SECTION 5. This Ordinance shall become effective at the earliest date permitted by law following the date of its enactment.
